## Memorandum regarding Indo-Bangla trade with reference also to Nepal and Bhutan

Greetings from CUTS!

- 2. CUTS International (<a href="http://www.cuts-international.org/">http://www.cuts-international.org/</a>) organised a Stakeholder Consultation on Indo-Bangla Trade on August 9, 2009 in Agartala, Tripura. This was in association with *Friedrich Ebert Stiftung* (FES), India and was targeted at building the momentum generated by the Joint Tripura-Bangla Task Force on Trade set up earlier this year.
- 3. Attached, please find a memorandum which emerged from the deliberations among the distinguished delegates from India and Bangladesh who attended the conference. The delegates included various heads of chambers of commerce as well as high profile representatives of civil society organisations and think tanks from both Bangladesh and India.
- 4. To build on the progress made by the consultations it was decided to form a Sub-Regional Independent Task Force on Connectivity and Cooperation, comprising representatives of civil society and business chambers from Bangladesh, India, Bhutan and Nepal. It was decided that there would be four (4) convenors of this task force, one from each country.
- 5. I am sending you this memorandum in my capacity as convenor of the mentioned task force from the Indian side. This is following the approval of my candidature through proposal and subsequent consensus.
- 6. We, the endorsers of this Memorandum (see list of endorsers below memorandum), request you to give the recommendations made therein due and urgent consideration so that international trade involving Nepal, Bhutan, India and Bangladesh can attain its full potential.

## **MEMORANDUM**

# Transpired from the *Agartala Stakeholder Consultation on Indo-Bangla Trade*Organised by CUTS International in association with FES, India On August 9, 2009 in Agartala

- 1. There is an immense potential for sub-regional cooperation in trade and investment between North East India and Bangladesh which needs to be effectively exploited and efficiently materialised.
- 2. Both Bangladesh and India can gain from connectivity/transhipment/transit which needs to be implemented on a reciprocal basis and should involve and benefit all other neighbouring countries i.e. Nepal and Bhutan. In this regard, a joint private logistical venture involving India and Bangladesh could be facilitated by business associations with the prior approval of the governments of Bangladesh and India.
- 3. The facilitation of efficient connectivity/transhipment/transit and logistical movements would require extensive upgradation of facilities at Land Customs Stations and approach roads on the border between North East India and Bangladesh.
- 4. Joint initiatives for capacity building of customs and immigration officials should be undertaken by the government agencies of Bangladesh and India. These initiatives should also aim to enhance efficiency and knowledge on issues such as HS codes, certification and documentation.
- 5. The port of *Mongla* in Bangladesh needs to be promoted as a potential source of maritime connectivity for all countries in the sub-region (Bangladesh, India, Nepal and Bhutan). Similarly, ports in *Ashuganj* and *Sherpur* should be promoted as sources of riverine connectivity.
- 6. People to people and business interaction between Bangladesh and North Eastern India needs to be encouraged. It is therefore essential to establish direct air connection between Dhaka and Guwahati and bus connection on the Dhaka-Sylhet-Shillong route. The proposed private airline connecting all the capital cities of North Eastern States which is being supported by the North Eastern Council should be extended to Dhaka and Paro to facilitate easy passenger travel from North East India to Bangladesh and Bhutan.
- 7. This consultation meeting has identified an urgent need for engaging civil society and private sector stakeholders in facilitating trade, investment and road and rail connectivity. A decision to form a 'Sub-Regional Independent Task Force on Connectivity and Cooperation', comprising representatives of civil society and trade bodies from Bangladesh, India, Bhutan and Nepal has been taken in this meeting. There will be four convenors of this task force, one from each country.
- 8. The Task Force will undertake advocacy initiatives and conduct necessary consultations to suggest ways and means to the policy makers in this region for the removal of trade barriers. The participants from Bangladesh and North East India in the Agartala meeting would act as the nucleus of this Task Force. CUTS International would coordinate the setting up of this task force by seeking representation from Bhutan and Nepal and would be assisted by the Bangladesh Enterprise Institute, Dhaka.
