Memorandum of Understanding ('MOU')

This Memorandum of Understanding (MOU) establishes a partnership between the Australian Risk Policy Institute (ARPI) and Consumer Unity and Trust Society (CUTS) International, India.

The purpose of the MOU is to promote awareness, understanding and application of ARPI's Strategic Risk Policy $^{\text{TM}}$ ('SRP') thinking, new approach and new framework, referred to as Risk 4.0, promoting and enabling protection of vulnerable consumers and infrastructure, in support of work undertaken by CUTS.

It is intended that this will occur through the delivery of ARPI's advisory services on an ongoing basis in general and specifically through joint projects such as developing an ethical framework for 6G which is now under consideration, and possibly later concerning social media, virtual nations and other matters of concern.

Both parties will carry their own costs regarding exploration of developing joint projects with a view to obtaining Government grants to implement joint projects.

ARPI advises government, corporate and community sectors through educational training and consultancies on SRP.
