It will focus on understanding the interrelationship between regulatory reform and good governance more generally. This session will consider the degree to which reform programmes have assessed the capacity of government and the existing levels of intra-government communication in order to determine the relevance and appropriateness of different tools and approaches. The design of regulation needs to take account of market conditions and meet the public interest. OECD Countries have used these principles and the analytical resources of the OECD to evaluate and improve their systems for regulatory management and achieve better regulatory outcomes.</p> <p>This session aims to identify particular challenges to the delivery of quality regulatory outcomes in India. It will draw on the analytical work of the OECD on the causes of regulatory failure and principles of regulatory quality. Topics will include; the use of evidence based approaches to policy development, reducing the burden of regulation on business, and institutional frameworks for improving regulatory outcomes.</p> <p>The session will also draw on contributions from regulators who will provide examples from specific regulatory sectors, and identify for discussion areas for improvement in regulatory processes.</p> <p>The OECD will circulate and present a recent OECD publication <i>Regulatory Impact Analysis: A Tool for Policy Coherence</i>.</p>
