# For the attention of road authorities in Jaipur



A few years ago, an old couple in Lucknow were found painting white stripes on a road bump. Their son was killed on the road as his motorcycle went flying after hitting the speed breaker, because it was built newly and did not carry white stripes.

Rather than cursing the municipal authorities for not highlighting the speed breaker, the old couple volunteered to do what the authorities did not do. Their reason was that they may have lost their son due to negligence, but did not want others to suffer the same fate.


I am not aware if the municipal authorities were shamed into taking action, but even if they were, I wonder whether this has become a routine affair.

Many would be surprised to know that there are ISI Standards which require the road construction agencies to build speed breakers of a particular dimension, paint them with white stripes like the zebra crossings, and put signboards a few metres before the bump to warn road users. Even if the bumps are painted with white stripes, they do not last long and have to be repainted on a regular basis.

In Jabalpur, I once saw something innovative and simple, environmentally friendly and long lasting. They used broken white ceramic chips to create stripes on the road bumps. Rains would wash away the grime and dust on it, thus they remained in operation for a very long time.

Speed breakers are good regulators for speeding vehicles, particularly dare devil two wheeler riders. Road safety experts believe in them. But how do municipal authorities behave? An example from Jaipur will tell you the sordid tale. I often travel between Queens Road and Prince Road to reach my house off the Kings Road. New speed breakers have been installed on various crossings at perhaps the same time, well and good.

The one on Prince Road at the entry point on Queens' road has white stripes, while the one at the end of the road where it culminates on the Ajmer Road there is no white stripes. At the entry point on Kings Road there are no white stripes, and it is a car breaker...a huge one. In any event all these speed breakers are too close to the turning points hence wrongly placed, and vehicles have to gun their brakes

to negotiate the bumps. As a result, many a vehicle coming from behind has crashed into the one ahead which has had to break suddenly to cross over the speed breaker. Some two riders have been thrown off their vehicles and road rage has also been witnessed. Fortunately, no one has been carrying a weapon to intimidate the other person.

I have not been to other new locations of newly installed speed breakers in Jaipur, but am sure the scene will be as lackadaisical as the one narrated above.

I do not even know who is responsible for this: is it the Jaipur Development Authority or the Jaipur Municipal Corporation or the State PWD? The roads in Jaipur are divided among them and hence there is a multiplicity of agencies who are doing the same job.

If a well informed person like me is ignorant, imagine the plight of the less informed person either living in Jaipur or visiting it from outside.

Can the authorities put up some helpline phone numbers around the city to let us know, so that we can at least call up and report such issues?

On the top of it, these helpline numbers need to be manned by responsive and responsible persons, so that efforts made could result in action. Otherwise people will just become apathetic. Are the authorities listening?

The study aims to highlight the key flaws in the design of Indian roads and develop a manual, first of its kind in India. The manual will contain suggestions/recommendations on 'remedial traffic calming strategies' for concerned policy/decision makers, primarily in the departments of Police, Transport, Municipal Corporation, Development Authority and Public Works. About 24 sites out of six locations would be studied for a detailed investigation of road crashes involving pedestrians.

CUTS HRC was formally launched in Hanoi, on February 29, 2008. This is the fourth overseas centre of CUTS International, opened with the aim of promoting trilateral development cooperation on a range of trade and economic policy issues.

CUTS HRC will be providing technical assistance to the VCAD, under the Ministry of Industry & Trade, over the period 2008-10 with support from the Government of Switzerland, in a capacity building project on competition policy and law. CUTS is also planning to provide support to the VCAD in the drafting of a law on consumer protection for Vietnam, bringing in its 25 years of experience working on the issue from India and other countries in the world.

Attending and speaking at the reception were Alice Pham, Director CUTS HRC; Pradeep S Mehta, Secretary General, CUTS; Lal T.
