Should There Be a Cap on Credit Card Interest Rates?



While the whole world is reeling under unprecedented financial crises, a small incident which concerns most of us may have gone unnoticed. It is about what banks can charge as interest on credit card outstandings. The issue has been raised with a recent

order of the National Consumer Disputes Redressal Commission (NCDRC) against some credit card issuing banks, such as Citibank, HSBC etc., which says that there should be a cap of 30 percent.

The defendant banks have gone to the Supreme Court in appeal claiming that capping of interest rates on credit card payments is contrary to Reserve Bank of India (RBI) policy. It has been pointed out by them that the central bank has allowed banks to prescribe their own respective ceiling rates of interest in respect of small value personal loans, which would apply to credit card dues as well.

The usual interest rate is high enough but where card holders 'revolve' credit or pay the 'minimum amount' the interest is about four times more than that on housing loans. Why? Credit cards have become a vehicle for credit expansion at extremely attractive rates for the card issuers. The card users are first lured to spend money, which they can not repay due to exorbitant rate of interest that leads them into a debt trap. Later they are encouraged to convert the outstanding into a loan. The banks do so to avoid an increase to their non performing assets, which dent their balance sheets.

Lately, industry-level delinquency has been on the rise primarily because of the high interest rates. It has been reported that India's outstanding credit card debt had touched Rs 26,500 crore in May 2008, up by 87 percent from May 2007. It has also been estimated that the default rates may increase to 9.5 percent over the next two years from 7.5 percent currently.

The RBI, however, continues to hold the view that credit cards are basically a 'payment facility' and refuses to change its stand. This interpretation is over simplistic for the very purpose of a credit card is to provide credit. 'The Credit Information Companies (Regulation) Bill, 2005' clearly categorises credit card



users as 'borrowers' as do many consumer credit regulations across the world. In the case currently before the Supreme Court, the main argument of even the defendant banks is based on the fact that they treat credit card outstandings as 'small value personal loans.'

Smaller developing countries, such as Thailand had prescribed a universal cap of 18 percent as being chargeable on credit cards many years back. The minimum monthly salary requirements for credit card holders were also raised there. In South Korea too, the interest rates and quantum of advances are regulated in addition to regulations on operations and pricing.

We believe that the order of the NCDRC restraining banks from charging interest rates in excess of 30 percent is also not good. Banks should charge interest as applicable to an unsecured advance.

CUTS has been trying to convince RBI to direct banks to charge a reasonable rate of interest on credit cards for over five years now by citing examples from around the world. We hope our readers can join us in this campaign.
