At the national level, we released our report on reorienting the Competition Law in India at a brainstorming meeting with our partner: NCAER. In the same period, the Parliament also adopted the new Competition Act, which will replace the old MRTP Act. I am very happy to say that we had lobbied hard on the new competition law and most of our recommendations have been accepted. The new law will be able to deal with several irregularities in our economy and help us to

grow faster.

The main problem in making it effective is a resource issue, both money and people. If the government doesn't give it sufficient money, it will not be able to do what it is required to do. "I am delighted to note that CUTS is celebrating its 20th anniversary in the year 2003. My first interaction with CUTS was back in 1984, when Shri Pradeep Mehta and Shri Tripuresh Sharma came to me with a campaign on the severe coin shortage in the country, asking legislators to sign on. This was perhaps the first campaign of its kind by the first consumer group of Rajasthan, which impressed me a lot. I signed on it, as one of the 44 legislators of Rajasthan. The campaign was successful, as I saw in the press.

CUTS is one of the very few consumer organisations in the country working from the grass root to international level. I have been seeing the organisation growing at an amazing pace.

When I was asked by the Bharatiya Janata Party in 2000, to draft the party's input for the National Agriculture Policy, I had to look around for guidance and inputs on WTO's impact on Indian agriculture. Few persons informed me that one does not have to look beyond Jaipur, when CUTS Centre for International Trade, Economics and Environment can assist me. Indeed, their expert comments and inputs helped me to draft the policy

I have been seeing a variety of CUTS' publications, especially the one which is in the form of a wall newspaper called "Gram Gadar". This wall paper has been helping our rural folk in a big way through its regular columns, such as on women's rights.

I congratulate Shri Pradeep Mehta and his team at CUTS for their great efforts and wish them good luck for a very bright future."

Competition Challenges

Under the 7-Up Project, which is a comparative study of the competition regimes in seven developing countries of the Commonwealth, a seminar was organised on "Competition Challenges in a Globalising Economy: Issues before India" in collaboration with the National Council of Applied Economic Research on 4 October in New Delhi.

Advocacy and Fact-finding

A series of regional seminars were held under the 'Investment for Development' (IFD) Project which involves fact-finding and advocacy work on investment regimes in seven developing countries, viz., Bangladesh, India, South Africa, Hungary, Tanzania, Brazil and Zambia.

The first in the series was the Africa Regional Seminar organised in Nairobi, Kenya, in collaboration with EcoNews Africa on 18-19 October. Discussions were carried out on the findings of the research carried out in Tanzania, South Africa and Zambia.

The Asia Pacific Regional Seminar held in New Delhi on 24-26 November was the second one in this series. The participants discussed Foreign Direct Investment (FDI) trends, policies, performance and perceptions of the region.

The third in the series was the Latin America Regional Seminar in Sao Paulo, Brazil, on 4-5 December. Various domestic and regional FDI issues of the region were discussed.

Another Asia Pacific Regional seminar was organised on 26 November at New Delhi to discuss the State of Competition Policy and Law. Resource persons made presentations on the current status of competition policy in their respective countries. Robin Brown of FEMAG, Australia, emphasised the need for cooperation among civil society organisations at the regional and international levels.

EU-India Project

A meeting of the EINTAD (EU-India Network on Trade and Development) Project was held in Jaipur from 20-21 December.

This Network is implementing a joint research project (comprised of European and Indian researchers) on various issues, such as mobility of labour, textiles and clothing, anti-dumping, competition and investment, in the context of the Doha agenda. One of the objectives of the research is to feed the outputs to trade negotiators well before the next WTO Ministerial Conference, which will be held at Cancun, Mexico, during September 10-14, 2003. The involvement of the poor and unprivileged communities should be increased by creating a better-informed society. The

India, EU and the WTO




