## **Creating Mountains Out of Valleys**



Three events of the recent past have really unnerved me, as if the nation has gone berserk and people have abandoned rational behaviour. Each of

them has happened mainly because of media hype, created out of a cutthroat competition among the different TV channels.

The first incident was the coverage on Prince – the kid who was rescued from 60-feet deep hole in Haryana. The second was the publicity over the test results of pesticide residues in soft drinks. While there is some merit in the first two, the same would not apply to the senile about-turn by Jaswant Singh in identifying the mole in the Prime Minister's Office (PMO).

One SMS that I received summed up the Prince episode thus: "The whole nation watched the recovery of Prince from a deep hole, but none seem to be bothered about the whole nation, which is in a deep hole". Many rushed to offer all types of rewards for Prince, including the Haryana Chief Minister, but none

said anything about hauling up the negligent digger who left the hole unprotected.

Thousands of people continue to fell into thousands of proverbial and actual manholes etc., but they do not even get a line in the media. Coming to soft drinks row, a similar report three years ago had led the Parliament getting into action. The Rajasthan High Court had asked the soft drink companies to write on their containers, whether they do contain pesticides or not. The matter is still pending before the Supreme Court. Anyway, we continue to consume harmful pesticides but can do little, except raise some noise.

For example, the banned and spurious drugs, which continue to be sold in the Indian market, and the government does not do anything. This is despite several efforts made by advocacy groups, government committees, parliamentary debates, etc.

We are currently having a debate on the drug pricing regime. The Fertiliser and Chemicals Ministry is trying to bring in an irrational discipline, which has been opposed by both the

Commerce & Industries Ministry and the Health Ministry. One of the arguments is that it will shy away investment, if we get into excessive regulation. The brouhaha over soft drinks could send a wrong message that we are singling out Multinational Corporations (MNCs) and would also scare away foreign investment. Third event certainly calls for a boycott as Jaswant Singh, its author, told the country that he would name the mole to the PM, and created a huge suspense. As a result, the respected scientist V S Arunachalam was incarcerated by an irresponsible media report. As is the wont, other TV channels followed blindly like the mice that followed Pied Piper. Who will compensate Arunachalam for the agony that he and his family suffered?

Whether it is Jaswant Singh's idea or his publisher's, controversies always help promote a book. Should not media stop covering such misleading claims directed to sell a book? It is high time the media inculcated ethics, else we will have worse scenario in future.

The workshop was organised in three sessions, which included presentations, group discussions and plenary sessions. In the workshop, papers were presented by Farmer Support Organisation (FOSUP), Export Board of Zambia (EBZ) and Vladimir Chilinya of CUTS ARC. The participants provided some useful recommendations against the

problems, such as lack of institutional structures and failure to plan for markets before production.

#### Sensitising the Youth

CUTS Centre for Human Development (CUTS CHD) organised a one-day great gathering at Bhilwara, Rajasthan, on August 12, 2006, to commemorate the International Youth Day in which around 150 people participated. The main agenda of the meet was early marriages and premature pregnancy.

The workshop addressed the need for youth to be endowed with legal knowledge in order to take appropriate decisions in making their future safe.

#### **Competition Policy Tools**

CUTS Centre for Competition, Investment & Economic Regulation (CUTS C-CIER), with the support of the World Health Organisation (WHO) and the Ministry of Health & Family Welfare (MoHFW), Government of India (GoI) organised a knowledge dissemination workshop on 'Options for Using Competition Law/Policy Tools in Dealing with Anticompetitive **Practices** Pharmaceuticals and the Health Delivery System', in New Delhi, on September 08, 2006.

The participants included health and competition experts, academics, NGO activists and representatives of business associations. There emerged the views that there should be a coordinated framework of regulation in the pharmaceutical industry and the health delivery system, including the hospitals, doctors, pharmacists and the diagnostic laboratories.

Presenting the study report, Nitya Nanda of CUTS, emphasised that the pharmaceutical and health delivery system is a peculiar case of market failure as consumers are not the decision makers.

#### Glimpses of Ongoing and Future Projects of CUTS

## CUTS Centre for International Trade, Economics & Environment (CUTS CITEE)

CUTS CITEE has undertaken the project 'Documenting advocacy practices involving local stakeholders with the process of trade and globalisation in four Indian States', with the support from Oxfam Novib, The Netherlands. Under the aegis of Oxfam International's Knowledge Infrastructure with and between Counterparts (KIC) initiative, the project intends to imbibe the GRANITE model by focusing on the poor countries, which are facing challenges of globalisation. It aims to empower the local stakeholders on issues of globalisation and trade, including the impact of such advocacy efforts. Case studies will be conducted in Karnataka, Rajasthan, Uttar Pradesh and West Bengal with the help of GRANITE Project partners.

## CUTS Centre for Competition, Investment & Economic Regulation (CUTS C-CIER)

CUTS C-CIER has undertaken a project, 'Study of Cartel Case
Laws Under the MRTP Act: Learning for the CCI'. It aims to
develop an approach for dealing with cartels in the light of the provisions of
the Competition Act. The project is being supported by the World Bank, and
implemented in collaboration with the National Law University, Jodhpur,
India. The research under the project would focus to analyse India'
experience of cartels under the MRTP regime and draw lessons from the
two jurisdictions of Brazil and US, for incorporating lessons for the CCI.

#### CUTS Centre for Consumer Action, Research & Training (CUTS CART)

CUTS CART has been appointed Ministry of Environment and Forests (MoEF), Government of India (GoI) as the Regional Resource Agency (RRA) for Rajasthan under the National Environmental Awareness Campaign (NEAC), for three years, i.e. from 2006-07 to 2008-09. The advertisement regarding the RRA for each states appeared in all the national news *dailies*, both in Hindi & English, on September 14, 2006. 'Solid Waste Management' is the theme for the campaign for the year 2006-07.

## CUTS Centre for Human Development (CUTS CHD)

CUTS CHD has been selected as the Mother NGO (MNGO) for Chittorgarh, Rajasthan under the 'Reproductive and Child Health (RCH)' scheme of the Ministry of Health and Family Welfare (MoHFW), Government of India (GoI). The objectives of the project broadly include utilisation and delivery of heath services for reduction in maternal mortality; reproductive mortality; infant mortality and fertility; improvement in maternal healthcare; addressing general healthcare issues; childcare; and family welfare through multi-stakeholder involvement and action.

#### CUTS Calcutta Resource Centre (CUTS CRC)

CUTS CRC has received a project from ActionAid International, India on the land reclamation by the

Government of West Bengal in three districts of state viz. Hooghly, Howrah and South 24-Parganas for industrialisation. The project, a four-month study initiative, would assess the livelihood impact of the farmers whose land has been taken away.

#### CUTS Africa Resource Centre (CUTS ARC), Lusaka

CUTS ARC has undertaken a one-year project entitled, 'Market Linkages' that will seek to link small-scale farmers, producers through district associations,



to the national, regional and global market. It will further highlight and address concerns about global trade and development as it affects sustainable livelihood in Zambia.
