S/he will also be supporting a session that CUTS will be jointly hosting with UNCTAD on Social Investments.

The ideal candidate must be fluent in the English language, both oral and written, have good writing skills, and have full proficiency in MS Office suite including Word, Excel, and PowerPoint. Excellent communication and interpersonal skills are required.

### **KEY RESPONSIBILITIES:**

The Intern will perform a wide range of duties including some or all of the following:

- Attend in-person sessions of the 8th UNCTAD World Investment Summit and rapporteur for the same;
- The candidate would be required to take notes during sessions and submit the same post;
- S/he will be required to give programme support for a session that CUTS International is organizing with UNCTAD during the summit.
