## Plastic Pollution: India Must Go Beyond Recycling

Plastic waste is choking cities, rivers, and oceans across the Global South. In India, despite bans and recycling targets, trash continues to pile up — from Jaipur's Central Park to rural waterways. Recycling helps, but it's not enough. India generates nearly 10 million tonnes of plastic waste annually, with over half of it mismanaged.

Much of our recycling is "downcycling" — turning plastic into lower-grade products that soon become waste again. The real solution lies in reducing use, reusing materials, and redesigning products. While India's 2022 ban on single-use plastics was a step forward, weak enforcement has limited impact.

We must shift to minimal, reusable, and eco-friendly packaging. Reuse models — such as refill stations and returnable containers — need stronger infrastructure and incentives. Alternatives like bioplastics are not always viable and may harm recycling systems. Instead, investing in truly circular, locally adapted materials is key.

India's EPR policy must be strengthened with transparency, innovation support, and local waste systems. Behavioural change is equally vital — reviving frugality and reuse through schools, temples, and influencers.

India has a chance to lead globally by aligning cultural wisdom with climate action. Ending plastic pollution requires more than cleanup — it demands systemic change.

### Extreme Poverty in India Falls to 5.3%

India's extreme poverty drops to 5.3 percent in 2022-23 from 27.1 percent in 2011-12, lifting 269 million people out of poverty, says World Bank. Despite a higher US\$3 poverty line, significant gains were made. Lower-middle-income poverty also fell from 57.7 percent to 23.9 percent during the same period.

Prime Minister Narendra Modi invited global investments in India's aviation sector, calling it a fast-growing industry with vast potential. He highlighted the new Indian Aircraft Act, which aligns with global norms, eases compliance, and offers major opportunities. ## CCI Notifies New Rules to Tackle Predatory Pricing

In a further bid to check predatory pricing and ensure fair competition, the Competition Commission of India has notified new definitions for various costs it will use to judge whether a price charged by a company for a product or service is predatory or not. According to the Competition Act 2002, predatory pricing is where a good or service is priced below its cost with the aim to reduce competition and eliminate competitors.

The Telecom Regulatory Authority of India's new consent mechanism pilot for spam control aims to harmonise with India's data protection law, addressing past failures due to poor coordination and enforcement.
