### **Why Indian CSR Must Back Think Tanks** to Realise Aatmanirbhar Bharat

Since its inception in 2013, India's CSR regime has mobilised over ₹34,900 crore annually, largely benefitting education, health, and rural development. Yet, an overlooked gap persists: minimal funding for policy research. In FY 2023-24, allocations to "technology incubators" were just ₹1.91 crore—an insignificant share of the CSR pool.

India's aspiration of becoming truly Aatmanirbhar requires not only schools and hospitals but also robust research, analysis, and evidence to shape resilient policies, competitive industries, and innovation. With GERD stuck at 0.64 percent of GDP—well below China, the U.S., and South Korea—India suffers a deep research deficit. Think tanks, critical to bridging government priorities and private innovation, remain underfunded, especially as international funding shrinks following FCRA restrictions.

The Companies Act already permits CSR contributions to R&D, incubators, and recognised institutions. What is lacking is corporate imagination. Even diverting 5-10 percent of CSR funds could create a ₹1,700-3,500 crore research corpus—far exceeding past foreign inflows.

Safeguards such as transparent processes, peer review, and oversight mechanisms can mitigate reputational risks. To truly achieve Aatmanirbhar Bharat, India must invest not just in factories but also in ideas, policies, and knowledge—CSR can be the catalyst.

#### India Slams Trump's H-1B Fee Hike

India criticised Donald Trump's move to impose a US\$100,000 fee on H-1B visas, warning of "humanitarian consequences" and alleging fear of Indian talent. The visas, vital for skilled roles in IT, healthcare, and engineering, allow six-year stays. India, the largest beneficiary, received 71 percent of approved H-1B visas in 2024.



#### 60% of India's FDI Flows to Tax Havens



Indian firms are increasingly routing foreign investments through low-tax jurisdictions to expand globally, experts and data reveal. RBI figures analysed by *The Hindu* show nearly 56 percent of overseas investments in 2024-25 flowed to hubs like Singapore, Mauritius, UAE, the Netherlands, UK, and Switzerland, underscoring India Inc.'s reliance on tax-friendly destinations.

#### Panel Seeks MCA Report on CCI's Digital Role

The Parliamentary Finance Panel has sought an action-taken report from the Ministry of Corporate Affairs on its recommendations regarding Competition Commission of India's (CCI) role in the digital sector. It highlighted ex-ante regulation, coordination with Ministry of Electronics and Information Technologyand other regulators, and addressing self-preferencing and predatory pricing. CCI confirmed collaboration to enhance trust, innovation, and resilience in India's digital economy.



#### **Private FM Radios May Air 10 Minutes of News**



The Telecom Regulatory Authority of India (TRAI) has recommended allowing private FM radio operators to broadcast up to 10 minutes of news and current affairs per hour, following the central government's programme code. It also proposed simultaneous online streaming without user-controlled features. The recommendations were part of TRAI's report on reserve prices for FM channel auctions.
